Minutes of the Meeting of the Council held in Matfen Village Hall on Monday 30th November 2015 at 7.00pm

- 0680. APOLOGIES FOR ABSENCE –** County Councillor Mrs V Jones
- 0681. PRESENTATION BY DAVID WILSON FROM THE STEPHEN CAREY FUND – DEFIBRILLATOR.** The Stephen Carey Fund was started in July 2012. They have two main suppliers; one for the defibrillators and one for the cabinets. Each comes with a ten year warranty. Once the equipment is purchased it becomes the property of the Parish Council however The Stephen Carey Fund will provide support. The equipment would need to be insured by the Parish Council. The installation is arranged by SC Fund. Total cost would be under £2000. The cabinet requires electricity and there is a key code lock on the front of the cabinet to gain access. Warm air circulates in the cabinet if the temperature falls below 5 degrees. It is a 24/7 public access device. The units are registered with the NE Ambulance Service and should a 999 call be made you would have to be within 500m of the cabinet to be sent to use the defibrillator. The SC fund provides training and it would be up to the Parish Council to raise awareness of these sessions which last for 2 hours. It costs approx £25 per year on electrics, every 5 years a new battery would need to be purchased £150, pads last 3 years £30 each and are one use only and the unit comes with 2 sets of pads. The unit is self checking however the SC fund asks for 2 community guardians (maintenance checkers) to check the unit once per fortnight to make sure all is well.
- 0682. PRESENTATION BY CUNDALLS RE PROPOSAL FROM MATFEN ESTATES.** Matfen Estates are looking to provide accommodation for families and larger groups and intend to submit a planning application early in the New Year for 30 single storey 2-3 bed lodges with associated parking on the Clare Wood Road to Whittington Mill. The access road will need to be improved and discussions are taking place with NCC Highways. The lodges will be made of timber, low energy, low carbon and sustainable. They will be modern buildings, lifted off the ground which will encourage ecology to grown around them. Each building will have a steep pitch roof and vertical timber cladding. There will be an energy centre on site and wood from the estate will be used to create energy for the site and heating of the lodges. The site will sit in woodland, screened with established trees and new bodies of water will be created on site. The area will be landscaped and mounded between lodges so they will not overlook each other. An underpass will be created for access from the hotel to the site. Plans of the site and lodges were available to view. Concerns were expressed of the impact on the community.

0693. VILLAGE ISSUES

- a) **RYAL ISSUES.** Email received from Matfen Estates advising that they will be replacing the existing surface of the unauthorised track across Ryal Village Green with a plastic reinforcement mesh system through which grass can grow. The work will be carried out in Spring 2016 when conditions are suitable for sowing grass seed. It was agreed that the width of the track should be one cars width with parking for 2 cars, one behind the other. Once this has been agreed the Parish Council will contact Northumberland County Council for their agreement. **Action: RB to advise Matfen Estates.**
- b) **PLAY AREA – INGOE.** A number of residents had contacted the Parish Council both for and against the proposed play area in Ingoe. The whole plan will be revisited after a meeting with the residents on site on 6 February 2016 at 10.30am.
- c) **INGOE GRASS VERGES AND VILLAGE GREEN.** Email received requesting protection of the vulnerable corners on the village green and also the fork on the road in the middle of Ingoe due to the number of delivery vehicles churning up the grass. **Action: RD to contact the resident involved.**
